Natural resource-related companies are companies operating in a capacity related to the supply, production, distribution, refining, transportation and consumption of natural resources. <b>Recurrent Investment Advisors, LLC</b> manages the portfolio of this Fund.	All income in the Fund is reinvested. Investors can buy and sell shares of the Fund on a daily basis. The <b>first investment</b> must amount to <b>at least 250,000.00 Euros</b> .

The charges paid are used to finance the costs of running the Fund, including the costs of distribution. These charges reduce the potential growth of investments.

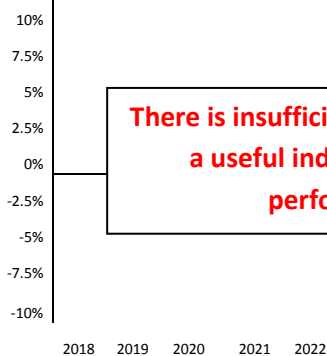
The **entry** and **exit charges** shown are maximum figures. In some cases investors may pay less—more details can be obtained from investment advisers or distributors.
