OBJECTIVES AND INVESTMENT POLICY

- The objective of InRIS Prentice (the “**Fund**”) is to achieve long-term capital appreciation by investing in equities (directly and indirectly through the use of financial derivative instruments (“**FDI**”)) issued by companies that have exposure to the U.S. consumer good sector, while delivering low correlation to equity markets. .
- The Fund will primarily invest in North America but may also invest from time to time in other markets (including up to 10% of its NAV in emerging markets).
- The Fund selects equities based on fundamental research and the use of primary data such as company public disclosures, market share, market prices, production, consumption, price or credit data. The Fund focuses on with the objective to make money on each position, whether long or synthetically short. The Fund has active long and short positions. Single stocks included in the portfolio are the result of a bottom-up selection process.
- The Fund will take long positions in companies experiencing prolonged under-performance, or undergoing significant change and take synthetic short positions through FDI in fully valued structurally declining companies.
- The FDI return is linked to movement in the underlying asset. A short sale involves the sale of a security that the seller does not own in the hope of buying the same security (or a security exchangeable for the same) at a later date at a lower price. A long sale does the opposite.
- The Fund will significantly invest in FDI for investment, efficient portfolio management, hedging and cash management purposes at any one time. For hedging purposes, the Fund may use FDI to hedge against fluctuations in the relative values of its portfolio positions due to changes in currency exchange rates.
- The Trading Advisor is free to choose how the assets of the Fund are invested within the limits of its investment policy.
- The Fund does not expect to pay a dividend. Any income arising is retained in the Fund and reflected in the value of the Share Class. Your Shares will be denominated in US Dollar, the Fund’s Base Currency.
- You may redeem your investment on the first Business Day of the month and every Wednesday and if such first Business Day of the month or Wednesday is not a Business Day, the preceding Business Day and/or such other day or days as the Directors may determine.
- Recommendation: this Fund may be appropriate for investors who have an investment horizon of three years or more.
- The Fund is actively managed with an absolute return approach. Solely by virtue of the fact that it uses the S&P 500 EUR Hedged Net Total Return Index (the “**Benchmark**”) for performance comparison purposes only, the Fund is considered to be actively managed in reference to the Benchmark. However, the Trading Advisor has full discretion over the composition of the Fund’s portfolio, which is not constructed with any reference to the Benchmark. The performance fee is not calculated with reference to the Benchmark.

Why is this fund in category 6?

The Fund is classified as category 6 as the risk of losing your investment is higher due to the level of volatility the Fund is exposed to having regard to the nature of its investments in equities but there is a chance of making higher gains. The below risk factors may impact the value of the Fund’s investments or expose the Fund to losses.

Risks materially relevant to the Fund which are not adequately captured by the indicator:

- **Equity Risk** – Equity risk and/or changes to the equity risk premium will have a significant impact on the performance of

the equities held in the Fund. Potential or actual change in any company’s financials held by the Fund could increase the level of perceived or actual risk.

- **FDI Risk** – FDI are highly sensitive to changes in the value of the assets they are based on. The leverage exposure of the Fund through the use of FDIs can be up to 100% of the Fund’s Net Asset Value.
- **Counterparty Risk** – The insolvency of any institutions providing services, such as safekeeping of assets or acting as counterparty to derivatives or other instruments, may expose the Fund to financial loss.
- **Liquidity Risk** – Some of the underlying investments of the Fund may be more difficult to buy and sell which may affect the Fund’s value.
- **Speculative Nature of the Trading Strategy** – The strategy is speculative and the Trading Advisor can engage in high volume short term day trading in times of increased market volatility which can involve a high degree of risk.

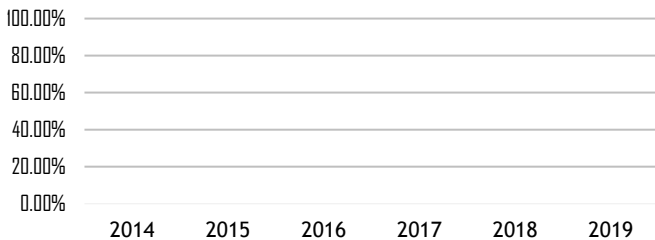

- The Fund was created on 1 July, 2019. The Share Class was launched on 3 February 2020.

- The performance figures are calculated in US Dollar, on the basis that all distributable income has been reinvested.
- Past performance is based on the NAV of the Share Class and is not a reliable guide to future performance.
