What is this product?

Type

- This product is a class of share of the Sub-Fund and denominated in USD. The Fund InRIS UCITS PLC is an open ended investment company with segregated liability between sub-funds authorised by the Central Bank of Ireland on 19 July, 2013 as a UCITS pursuant to the UCITS Regulations.
- As an investment fund, the return of the Sub-Fund depends on the performance of its underlying assets.

Objectives

Investment objective The investment objective of the Fund is to achieve risk-adjusted absolute returns from investment in catastrophe bonds, also referred to as cat bonds.

Investment policy

- The Fund will aim to achieve its investment objective by investing up to 100% of its Net Asset Value in cat bonds.
- Cat bonds are securities where the coupon and/or redemption depends on the occurrence of insured events (e.g. natural disasters, pandemics, disasters caused by explosion or fire, aviation disasters or similar rare insured events). An insured event is a phenomenon that occurs at a particular time, at a particular place and in a particular manner, thereby triggering the payment of insurance claims.
- Typically, cat bonds are unrated, floating rate instruments, but can also be structured with fixed or zero rate coupons and have maturities mostly between 1-4 years. The Fund will be exposed to cat bonds with varying maturities. Cat bonds do not embed derivatives or leverage.
- Cat bonds may be issued by special purpose vehicles ("SPVs"), public, private and semi-private insurance and reinsurance companies, governments, supranational institutions or corporations and may be admitted to official listing on a stock exchange or traded on another regulated market.
- Investments may be made worldwide and in any currency. The Fund may invest more than 20% of its Net Asset Value in emerging markets. The cat bonds in which the Fund will invest may be exposed to all possible natural disaster risks. The Fund will not invest more than 10% of its Net Asset Value in cat bonds which are exposed to (i) man-made events (such as cyber-crime and terrorism) or (ii) life and health extreme events (such as pandemics).
- The Sub-Fund is actively managed with no reference to a benchmark.

- The Sub-Fund promotes, among other characteristics, environmental or social characteristics, or a combination of those characteristics in compliance with Article 8 of the Sustainable Financial Disclosure Regulation ("SFDR").
- Given the above objectives and the risk and reward profile of the product, the recommended holding period is 5 years.

Redemption and Dealing: You may subscribe or redeem on a weekly basis, on each Business Day as defined in the prospectus, no later than 4 p.m. (Irish time) 1 Business Day preceding the relevant valuation day for subscriptions and 5 Business Days preceding the relevant valuation day for redemptions.

Distribution Policy: This product does not pay dividends. Income generated by the Sub-Fund is reinvested and included in the value of your share.

Intended investor

The typical investor profile is expected to be an investor seeking to take medium or long-term exposure to insurance-linked securities, who can afford to be exposed to the risks associated with this Fund, and who has a medium to high risk appetite.

The recommended investment period is between 5 and 10 years.

Term

This product was incorporated for an undefined period. The manufacturer may not terminate it unilaterally. Only the board of directors of the Fund or a general meeting of shareholders may decide to terminate this product.

What are the risks and what could I get in return?

Risks



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because it is not able to pay you.

The product is classified in the category 2 out of 7, which is a low risk class.

This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact the capacity of Alma Capital Investment Management to pay you.

Not all risks affecting the Sub-Fund are adequately captured by the summary risk indicator.

This rating does not take into account other risk factors which should be considered before investing, including Trading Advisor risk, Valuation risk, risks associated with Investment in Cash and Money Market Instruments, as well as Legal, Tax and Regulatory Risk.

This rating does not take into account the specific risks associated with investment in cat bonds, including conflicts of interest, capital risk, event risk, model risk, volatility and liquidity risk, seasonality risk, sourcing risk, insurance risk and correlation risk.

Performance scenarios

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product. They are based on the following regulatory assumptions: (i) in the first year, you would get back the amount that you invested (0% annual return) and, for the other holding periods, the product performs as shown in the moderate scenario and (ii) \$ 10,000 is invested.

How long should I hold it and can I take money out early?

Recommended holding period ("RHP"): 5 years

The RHP has been defined by taking account the above investment policy and risk and reward profile. You should be prepared to stay invested for at least 5 years. However, you can redeem your investment without penalty prior to the end of the RHP or hold the investment longer. Redemptions of shares will be effected each valuation day provided that the redemption notice has been received no later than 4:00 p.m. (Irish time) five (5) Business Days before the relevant valuation day. Applications received after that time will be considered for the following valuation day. The Sub-Fund reserves the right to impose an "anti dilution levy" in the event of receipt for processing of net subscriptions and/or redemptions, including subscriptions and redemptions which would be effected as a result of requests for conversion. Any cashing-in before the end of the recommended holding period may have a negative consequence on your investment.
